SETTINGS FOR CRIMINAL JURY CASES

Docket Call and Pre-Trial Hearings: September 13, 2017 at 10:00 a.m.

Non-Jury Date: October 23, 2017 at 10:00 a.m.

Jury Week: October 24, 2017 at 10:00 a.m.

1. Docket Call

Cases will be called in the order listed; however, trial of the case will be in such order as may be deemed convenient by the Court in the interest of efficient judicial administration. Docket call will be by personal appearance in court by the attorney of record.

2. Pre-Trial Motions and Hearings

Motions referred to in Articles 28, 39, 46, and other applicable articles of the Code of Criminal Procedure must be filed at least seven (7) days before the date and time set for pre-trial hearing. Pre-trial shall be immediately following docket call unless set otherwise in writing.

Attendance at pre-trial hearing shall be by the defendant, in person, and by the attorney who will be trying the case.

Exceptions to the filing deadline for pre-trial motions must be taken up with the Court. All motions not presented at pre-trial are waived. If no written order setting the motions for a time other than immediately following docket call is obtained and filed, motions not heard immediately following docket call are waived.

3. Guilty Pleas

Pleas of guilty must be announced at Docket Call and shall be disposed of at the next guilty plea docket unless a different date is requested of and set by the Court.

4. Trial on the Merits

Jury selection shall begin at 10:00 a.m. Jury questionnaires are mailed to prospective jurors and returned to the County Clerk. Copies will be available from the County Clerk as early as practical preceding trial.
