***Note- (RMP)- Records Management and Preservation- In accordance with Local Government Code 118.0546, Records Management and Preservation fee of \$10 is collected with any civil/family case or ancillary pleading, \$5 to District, \$5 to County.**

***Note- (CHS)- LGC 291.008 (d)- A fee of \$1 for filing any document not subject to the security fee. All Pleadings indicated below should include these additional fees.**
