Notice is hereby given that the polling places listed below will be open from 7:00 a.m. to 7:00 p.m. Tuesday, November 2, 2021 for the purpose of adopting or rejecting the eight constitutional amendments proposed by eight joint resolutions, as submitted by the 87th Regular Session of the Texas Legislature convened in January of 2021 in accordance with Article III, Section 5 of the Texas Constitution and Section 301.001 of the Texas Government Code.




